

Financial Resources Available to nonprofits in response to COVID-19

Below is a list of resources we think are most likely to be helpful to the many nonprofits in our community who are facing challenging financial times. This is simply our guidance on the resources nonprofits should look into – it's not a comprehensive list and is not meant to be official information. It's a gathering of the resources we are seeing out there and our best attempt at summarizing the key points. Please seek counsel from your attorney, accountant, banker, and staff for more detailed and official information.

FEDERAL FUNDING AVAILABLE – via the Senate CARES Act

• SBA Economic Injury Disaster Loan (EIDL) - Company/Organization has less than 500 employees

These grants provide an emergency advance of up to \$10,000 to small businesses and private non-profits
harmed by COVID-19 within three days of applying for an SBA Economic Injury Disaster Loan (EIDL). To access
the advance, you first apply for an EIDL and then request the advance. The advance does not need to be repaid
under any circumstance, and may be used to keep employees on payroll, to pay for sick leave, meet increased
production costs due to supply chain disruptions, or pay business obligations, including debts, rent and
mortgage payments.

This loan is available now. You do NOT apply through the Bank for this loan. Applications are submitted directly to the SBA.

Amount Available: Loan up to \$2,000,000 with cash advance of \$10,000 from the SBA. The link to apply can be found here. https://disasterloan.sba.gov/

Deadline: ASAP

• SBA Paycheck Protection Program Loan (PPP) – Company/Organization has less than 500 employees
The program would provide cash-flow assistance through loans. If employers maintain their payroll, the loans
would be forgiven (up to 8 weeks of payroll and a few other expenses). Small businesses/organizations will be
able to apply if they were harmed by COVID-19 between February 15, 2020 and June 30, 2020. This loan will be
available through SBA-approved banks. You are encouraged to apply through your existing bank – most of which
are participating in this program.

Amount Available: 250% of the average monthly "payroll" costs (measured over the 12 months preceding the loan), up to \$10,000,000. A portion of the loan may be forgiven – if you spend it within 8 weeks of receiving the loan – and if you maintain FTEs. If employees have been laid off, they need to be re-instated by June 30 to not be penalized.

Deadline: Applications can be submitted April 3 – June 30, 2020. We are being told the Treasury's intent is to provide funds to anyone that needs it. There is reason to move forward, but no need for panic.

STATE FUNDING AVAILABLE – via Michigan Economic Development Corporation

Funds distributed through local Economic Development Organizations

- Grants up to \$10,000 available to companies/organizations with 50 employees or less, that can demonstrate a
 need for capital to meet payroll and rent/mortgage expenses, and are able to demonstrate a loss of income as a
 result of the COVID-19 outbreak or the Executive Order.
- Some application deadlines have already passed, others are approaching quickly. Kent County (closed April 1), Ottawa County does not apply to nonprofits (closing April 6). Visit local EDO website for application and deadline details.

LOCAL FUNDING AVAILABLE – Michigan

Coronavirus Response Fund Grants – Heart of West Michigan United Way in partnership with local funders
and the Essential Needs Task Force. The fund will support nonprofits in Kent County who are serving vulnerable
populations throughout the county to meet their basic needs including shelter, food, resources to maintain
employment and to sustain themselves during unemployment. Applicants must be a local 501(c)(3) non-profit
human service organization or a community collaborative/group using a fiscal agent and must continue to
provide services during the COVID-19 pandemic.

Heart of West Michigan United Way will be accepting applications from local non-profits on a continuous basis. The Fund is granting awards up to \$25,000. If you have questions, please contact Emily Schichtel at eschichtel@hwmuw.org or at (616) 752-8601.

• Community Foundation for Muskegon County/Lakeshore United Way. A COVID-19 Response Fund has been created to mitigate the impact of coronavirus on local families and members of the community. The funds will be used to support organizations on the front line serving the Muskegon County community and will provide unrestricted operating support to community organizations providing essential services and addressing emergent and unanticipated community needs resulting from the pandemic. The intent of this fund is to support both immediate needs, as well as gaps in supports that emerge after local, state, federal, and philanthropic resources are realized.
